B. YOU SHALL IMMEDIATELY PROVIDE TO YOUR SUPERVISOR THE FULL NAMES OF ALL OCCUPANTS IN YOUR RESIDENCE & ADVISE YOUR SUPERVISOR IN WRITING OF ANY CHANGES IN THE PEOPLE WHO RESIDE AT YOUR RESIDENCE;

4. CURFEW

5. VERIFICATION

DURING THE PERIOD OF TIME THAT YOU ARE REQUIRED TO BE IN YOUR RESIDENCE WHILE UNDER HOUSE ARREST OR CURFEW:

A. YOU SHALL PHYSICALLY PRESENT YOURSELF TO YOUR SUPERVISOR OR TO ANY PEACE OFFICER WHO ATTENDS AT YOUR RESIDENCE; AND

B. YOU SHALL SPEAK TO YOUR SUPERVISOR AT TELEPHONE NUMBER _____ WHENEVER YOUR SUPERVISOR TELEPHONES YOUR RESIDENCE. THIS TELEPHONE NUMBER MUST NOT UTILIZE A CALL TRANSFER SERVICE & YOU MUST RESTRICT THE USE OF THE TELEPHONE LINE TO 15 MINUTES OF CONSECUTIVE USE OR LESS SO THAT YOUR SUPERVISOR CAN CONTACT YOU.

C. YOU SHALL NOT POSSESS ANY CELLULAR TELEPHONE, PAGING DEVICE, PORTABLE TELECOMMUNICATION DEVICE OR ANY OTHER ELECTRONIC DEVICE (INCLUDING BUT NOT LIMITED TO BLACKBERRY OR SIMILAR DEVICE), OR A RADIO SCANNER THAT IS CAPABLE OF SENDING OR RECEIVING ELECTRONIC MESSAGES OF ANY KIND WITHOUT THE WRITTEN PERMISSION OF YOUR SUPERVISOR & FOR PURPOSES PERMITTED BY YOUR SUPERVISOR.

6. EXCEPTION TO HOUSE ARREST & CURFEW

YOU MAY BE ABSENT FROM YOUR RESIDENCE DURING ANY PERIOD OF HOUSE ARREST OR CURFEW FOR THE FOLLOWING REASONS ONLY:

- i. TO ATTEND AT AN EDUCATIONAL INSTITUTION TO TAKE COURSES OR TRAINING APPROVED BY YOUR SUPERVISOR;
- ii. TO ATTEND AT YOUR PLACE OF EMPLOYMENT, OR AT ANY OTHER PLACE WHERE YOU ARE SEEKING EMPLOYMENT;
- iii. TO PERFORM ANY COMMUNITY SERVICE OBLIGATIONS;
- iv. TO ATTEND APPOINTMENTS WITH YOUR LAWYER, OR ATTEND COURT AS REQUIRED BY LAW;
- v. TO ATTEND FOR MEDICAL, DENTAL OR HEALTH APPOINTMENTS FOR YOURSELF, SPOUSE/PARTNER, OR DEPENDENT CHILDREN RESIDING WITH YOU AT YOUR APPROVED RESIDENCE;
- vi. TO ATTEND FOR ANY ASSESSMENT, TREATMENT OR COUNSELING AS DIRECTED BY THE COURT OR DIRECTED OR APPROVED BY YOUR SUPERVISOR;

IN THE EVENT OF SUCH EMERGENCY, YOU SHALL GO DIRECTLY TO THE NEAREST MEDICAL FACILITY & YOU SHALL RETURN TO YOUR RESIDENCE AS SOON AS POSSIBLE AND IMMEDIATELY NOTIFY YOUR SUPERVISOR OF YOUR ABSENCE, THE LOCATION YOU ATTENDED, AND THE SPECIFIC REASONS FOR THE ABSENCE. YOU SHALL PROVIDE TO YOUR SUPERVISOR SATISFACTORY PROOF OF THE EMERGENCY TREATMENT.

AT ALL TIMES WHEN YOU ARE ABSENT FROM YOUR RESIDENCE, YOU SHALL CARRY A LEGIBLE COPY OF THIS ORDER, INCLUDING ANY AMENDMENTS & ANY WRITTEN APPROVALS SIGNED BY YOUR SUPERVISOR. YOU SHALL PRODUCE THESE DOCUMENTS TO ANY PEACE OFFICER OR PERSON RESPONSIBLE FOR THE ENFORCEMENT OR SUPERVISION OF THIS ORDER UPON REQUEST.

7. PASSPORT

YOU SHALL IMMEDIATELY SURRENDER TO YOUR SUPERVISOR ANY PASSPORT THAT HAS BEEN ISSUED TO YOU & YOU SHALL NOT POSSESS A PASSPORT ISSUED BY ANY COUNTRY NOR APPLY FOR OR RENEW A PASSPORT FROM ANY COUNTRY.

8. 27. 35. Exemption

WHERE APPROPRIATE YOUR SUPERVISOR MAY GRANT TEMPORARY WRITTEN EXEMPTION FROM ANY OF THE TERMS OF THIS ORDER, PROVIDED THAT THE EXEMPTION IS FOR THE PURPOSES OF ADDRESSING AN IMMEDIATE NEED WITH RESPECT TO YOUR REHABILITATION OR FOR A HUMANITARIAN PURPOSE.

36. Definitions

IN THIS ORDER:

- (a) "RESIDENCE" MEANS THAT RESIDENCE WHICH HAS BEEN DESIGNATED BY THE COURT OR APPROVED BY YOUR SUPERVISOR FROM TIME TO TIME;
- (b) "CURFEW" MEANS THAT PERIOD OF TIME WHEN YOU ARE REQUIRED TO REMAIN WITHIN YOUR APPROVED RESIDENCE AS SET OUT IN THIS ORDER;
- (c) "HOUSE ARREST" MEANS THAT PERIOD OF TIME WHEN YOU ARE REQUIRED TO REMAIN WITHIN YOUR APPROVED RESIDENCE AS SET OUT IN THIS ORDER; AND
- (d) "SUPERVISOR" MEANS A PERSON DESIGNATED BY THE ATTORNEY GENERAL, EITHER BY NAME OR BY TITLE OF OFFICE, AS A SUPERVISOR FOR THE PURPOSES OF SECTION 742.1 TO 742.7 OF THE CRIMINAL CODE (AS AMENDED) & INCLUDES THAT SUPERVISOR'S DESIGNATE OR AGENT.
