

FASD BAIL / PROBATION CONDITIONS

These are the things I have to do until the court decides what to do about the thing the police say I did, and/or

I understand that I will owe the government \$500.00 if I do not obey this order:

MANDATORY

- I will stay out of trouble and follow all laws
- I must come to court when either the judge or _____ (insert name of probation officer or bail supervisor) tell me to. The next time I have to come to court is _____ (insert place, day, date and time of next appearance)
- I must tell either the court or _____ (insert name of probation officer or bail supervisor) if I change the place where I am living or where I work or where I go to school. The telephone number of (insert name of probation officer or bail supervisor) is _____
- The court is located in Red Deer at 4909 48 Ave and the telephone number is 403-340-5250.
- I must tell my bail supervisor / probation officer right away if I change where I live, where I work, or where I go to school and gives me a letter with his/her approval, or
- I will tell the RCMP/ Municipal Police agency right away if I move away from _____ if I need to talk to him/her about anything, or
- I must report to the bail supervisor/ probation office today _____ (give location and/or phone number) I must see my bail supervisor / probation officer again when they tell me to.

RESIDE

I must live at the place my bail supervisor/probation officer (insert name) tells me to live and not live anywhere else unless he/she first says it ok, or

I must live at the place my bail supervisor/ probation officer tells me to live. I cannot live anywhere else unless my bail supervisor/ probation officer says it is ok and gives me a letter with this information.

TIME CURFEW

I must be in the place I am living at every day between _____ PM and _____ AM and I must not leave it during that time.

My mom/ dad/ parents/probation officer/ bail supervisor may let me stay out later than _____ PM or leave the house before _____ AM but he/she must write down the time I have to be back in or can leave early, sign it and give it to me before I leave the house. I must carry that written note with me when I am out and show it to the a police if one asks me why I am out late or why I have left the house early, or

I will stay in the place where I live from _____ at night to _____ in the morning.

SCHOOL / WORK

- I must go to school every day. I must behave and follow the rules when I am at school. I must go to all of my classes unless my principal tells me something different. I must do all of my work in class and any homework I am given. Or
- I must give proof to my probation officer that I am looking for a job. I need to prove that I have applied for at least _____ (insert number) jobs in a _____ (insert week or month) or a number I am told by my probation officer.

I must put effort into:

a. Looking for a job

I need to tell your probation officer what I have done to look for a job.

b. Keeping a job I have

I need to tell my probation officer what I have done to keep my job.

My bail supervisor / probation officer can get a copy of my school or work records

NON - ATTENDANCE

I cannot go to any places that sell alcohol except that I may go to a restaurant to eat but may not drink any alcohol while I am there, or

I cannot go to any places that sell alcohol. I cannot go to a liquor store and I cannot accept alcohol or street drugs from any one.

ABSTENTION

I cannot use anything that can make me high or drunk or intoxicate me. This includes things like:

- Alcohol
- Street drugs
 - Marijuana
 - Cocaine
 - Ecstasy
 - Any other illegal street drug
 - Medical drugs not given to me by a doctor
 - It also includes more drugs than what my Doctor told me to take

*These are examples only

I must give a police officer a sample of my breath or urine if he/she asks for it. The police officer must have a good reason to tell me to give a sample.

REPETITION AND REMEMBERING

I must read this bail/ probation order every day and keep it with me wherever I go.

When my bail supervisor/officer _____ (insert name) tells me to go somewhere or do something. I will write it down right away and keep it with me all the time until I have done that thing or gone to that place.

Whenever I go to see my bail supervisor/officer _____ (insert name) , I should show him/her my bail/probation order, if he/she asks to see it, I will and tell him/her the things I have done to follow the conditions on the order since I last talked to him/her, or

INTERIM REVIEWS

I must come back to see a judge on _____ (insert date, time and place) so that he/she can see how I am doing and tell me when I have to come back again, or

I will come back to court on _____ (insert date, time and place) for a review because the Judge wants to see how I am doing.

WEAPONS RESTRICTIONS

I cannot carry anything on me that is meant to be used as a weapon. This includes things like knives, clubs, guns, or anything else that can be used as a weapon.

I can have these things only if they are needed for school or for my job.

I cannot buy or own anything that can be used to light a fire, like matches or a lighter. I cannot buy or own anything that is an explosive substance or device.

CONTACT RESTRICTIONS

I cannot contact _____ (insert name). That means I cannot call, write to, e-mail, text, or use Skype, Tweet, Facebook, or any other way of sending him/her a message. That also means I cannot get someone else to take the message for me.

I also cannot contact any other person that my bail supervisor/ probation officer _____ (insert name) tells me in writing not to contact, or _____ (please insert some wording as above)

My bail supervisor/ probation officer may give me a list of people I cannot hang around with or talk to. I have to stay away from them. I cannot get anyone to go see them for me.

I will stay 100 metres away from this place: _____. I can go to this place just once to get my things, but **ONLY** with the police.

I cannot be in or on any motor vehicle, like a car truck or motorcycle:

- unless the registered owner of the motor vehicle is there
- unless I have the written permission from the registered owner to be there
- Unless I am a passenger in a bus or taxi

TRAVEL

I must have to get a letter from my bail supervisor / probation officer to go out of Alberta.

RESTITUTION

COMMUNITY SERVICE

I will do _____ hours of community service work before _____. I must prove to my probation officer that I have done them.

ASSESSMENT / COUNSELLING

I must see my FASD counsellor/ mentor _____ (insert name) today and come back to see him/her whenever he/she tells me to.

I must also go for help with my addictions to alcohol and/or drugs. My bail supervisor/officer _____ (insert name) will tell me where to go and when to go there. After I go there I should tell my bail supervisor / probation officer _____ (insert name) the next time I see him/her where I went, what I did and when I have to go back, or

I must take counselling that my bail supervisor/ probation officer tells me to. I have to finish it. I am the one who has to prove that I have finished it.
